We are now offering universal 3 and 4 year-old free early education for 15 hours per week. **Children are eligible for the universal entitlement the term after their 3rd birthday.**

Additional Information:

- Pre-School pupils (aged two to three) must attend at least five sessions per week.
- Nursery pupils (aged three to four) must attend at least 8 sessions per week.
- These sessions can be a mix of mornings and afternoons, but please note afternoon sessions can only be booked when following a morning session on the same day (to create a full-day booking).
- We do not offer stand-alone afternoon sessions.
- Invoices will be sent termly and are payable prior to the start of each term.
- Where possible additional sessions should be pre booked a term in advance.
- Cancellation of any sessions requires a term's written notice in advance.
- Ad-hoc sessions may be available and booked through My School Portal.
- Prices include a midmorning snack, milk, hot two course lunch, all specialist lessons equipment and consumables.
- Childcare Voucher Schemes can be used to pay Nursery fees.
- In line with our terms and conditions notice is required a full term in advance otherwise a term's full fees will be liable (fees in lieu of notice).

Government funded free 15 hours will be applied as follows:

- Each morning session Monday to Friday 8.30am to 11.30am term time only, plus week 1 and week 2 of Summer Camp. (Term times will be the usual Ruspini House dates as per the website).
- We are unable to apply the government funding to ad hoc sessions.
- In order for us to claim within the terms and conditions of the Universal 3 and 4 year old scheme you will need to provide us with a parent declaration form, or we will not be able to make a claim and full fees will apply.
- Please also be aware that to the extent that the school is unable to claim early years funding for attendance, fees due will be exclusive of funding.
